3. The Regional Administrative Secretary now invites sealed tenders from tenderers registered with Contractors Registration Board in class IV and above for carrying out the Construction of Regional Commissioner's residence on plot no. 2014 Msasani Peninsular at Dar es salaam – Region.
4. Tendering will be conducted through the National Competitive Bidding (NCB) procedures specified in the Public Procurement of Goods, Works, Non Consultant Services and Disposal of Public Assets Regulations, 2005.

Box 5429, Dar es Salaam.** The tenderers may obtain further information at the same office.

All tenders must be accompanied by **Tender Securing declaration in the format provided in section 'X'** shall be filled in, enclosed in separate plain inner envelope and marked '**Original**' and '**Copies**' as appropriate, sealed in one plain outer envelope and properly addressed to "**Secretary, Regional Tender Board, P.
